## OFFICE MEMORANDUM

**Sub: Submission of Annual Immovable Property Return (AIPR) for the year 2025.**  
**(REMINDER)**

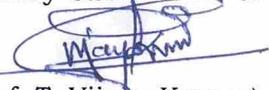
This is in continuation with Office Memorandum F.DTU/Vig.217/2017/1654 dated 31.12.2025, whereby every University employees holding a Group 'A' and Group 'B' post were requested to submit their Annual Immovable Property Return (AIPR) for the year 2025 **latest by 31.01.2026** to the Vigilance Section.

This is to emphasis that the AIPR is to be submitted in January every year in respect of the preceding year. Under the provisions of Rule-18 (1) (ii) of CCS (Conduct) Rule-1964.

Further, attention is also drawn towards DoPT OM No.104/33/2024-AVD-IA dated 09.10.2024, which stipulates that the employee who do not submit the AIPR by 31<sup>st</sup> January, **would be denied vigilance clearance and will not be considered for**

- (i) Inclusion in the offer list
- (ii) Empanelment
- (iii) Ex-India study leave
- (iv) Any deputation for which clearance is necessary and extension thereof
- (v) Appointments to sensitive posts
- (vi) Assignments to training programmes except mandatory training
- (vii) Confirmation in service
- (viii) Retirement on VRS
- (ix) Post-retirement commercial employment
- (x) Pre-mature repatriation (voluntary) from any deputation

In view of the DoPT O.M. with revised guidelines regarding grant of 'Vigilance Clearance' dated 09.10.2024, it is reiterated that failure to ensure timely submission of AIPR would result in denial of Vigilance Clearance.
